## GBYC Storage Winter Agreement Contract 2023-2024 page 2

This agreement is made between the Green Bay Yachting Club, Inc (hereinafter GBYC) and the member in good standing (hereinafter "Member"). That Member wishes to store his/her boat at the GBYC land storage facility during the 2023/2024 Winter Storage Season which starts 9/1/2023 and ends 6/1/2024. In consideration of said storage, Member agrees as follows:

1. To prepay the winter storage charges as calculated here on this document.
2. To keep the stored boat insured at all times against claims for property damage caused by said boat or damage to said boat.
3. To remove the boat from storage by June, 1<sup>st</sup>, 2024. If the boat is left stored after June 1<sup>st</sup>, 2024, an additional Summer Storage Fee will be charged equal to one-fourth (1/4) of the total winter storage fee (excluding lift-out/lift-in) per month until October 1<sup>st</sup>, 2024, at which time the next Winter Storage season contract will be charged according to the prevailing rate schedule.

If summer storage is requested due to hardship or extenuating circumstances, the Fleet Captain must receive a written letter from the member requesting that he/she be allowed to keep their boat on shore. This letter must include an explanation of why the boat must be kept in storage and what arrangements will be made to do something with the boat in the future. The Fleet Captain will then review your letter (with the board if necessary) and decide if extended storage is to be allowed.

4. That GBYC shall have a lien upon said stored boat in the amount of the unpaid storage charges until the storage charges are paid in full. That member shall pay said unpaid storage charges prior to removal of said stored boat from the GBYC land storage area.
5. That at such time as unpaid storage charges accrue to a total of \$750, GBYC will send written notice to Member and to any secured parties identified by Member of this agreement pursuant to Section 779.43 Wisconsin Statutes informing Member and the lien holder of what steps must be taken to secure release of the stored boat. That in event said storage charges are not brought current within 30 days after the mailing of the written notice referred to in this paragraph, GBYC may enforce its lien as provided for in Section 779.48(2), 409.501, and 409.507 Wisconsin Statutes. All mailings will be to the address of the Member listed on this Agreement and to the address of the secured party listed on this agreement.
