All dock applications are in and the dock assignment committee will be meeting in mid February. If you are not sure that you have the minimum 18 hours of GBYC work time necessary to hold a dock, check the member hour's list located in the upper right-hand drawer below the large screen TV. If you are short on hours, contact me ASAP before the dock assignment meeting. We will "very soon" need a small work group to connect the winter dock cables.



Requests from existing dock holders for a change in dock assignment will also be discussed at this meeting. Please note that committee decisions must factor in not only a member's seniority as a full member but also how long it has been since they requested the dock change.

If you are a full member but do not hold a dock at the GBYC (e.g. you trailer your boat, have a dock somewhere else, etc.) but someday may want a dock at the GBYC, your "rank" on the Floater List will be a factor in your success. So even though we have open docks at this time and you don't need one, you may want to be on the floater list just in case those situations change.

Also note that if your current boat insurance expires before or during the boating season, the GBYC needs a copy of the insurance renewal.

Remember to unplug your boat when not on GBYC property.

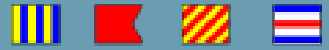
