We also filled the fuel tank with mid grade fuel with no ethanol the price at the pump will be determined ( should be around 3.60 ish ) We know by buying it early is taking a chance. But sometimes that's the way it goes. Wait till summer when every place else is over 4 dollars.

Make sure you get your dock fees paid for 2013. We will be doing dock assignments in the beginning of march so if you would like to keep you existing dock please pay for it or you may lose it. I know everyone is worried about the water levels but we still need to go forward with the club procedures. Hopefully we get a lot more rain and snow to get the water back up to safe levels for boaters.

Our financial committee has been looking at our credit card fees and they were pretty high last year. So if you or your guests need extra cash please get it from our ATM that is why it is there. That's one machine that always seems to pay. We are also charging an extra 5% on all dues and dock fees paid with a credit card. If you are out for the friday fish or other club meals feel free to pay with you card. It's the real small and larger draws that's hurting us.

I hope this boating season is better than the snowmobiling season was this winter. I bought some used sleds and got to use them 3 times that's over a thousand dollars a ride. And I thought boating was expensive. If the water don't come back up I'll have to find a new hobby. Maybe sky diving! The sky always seems to be there.

## Fleet Captain - Don Smith

Pray for lots of snow or rain to raise our harbor water levels! If this doesn't happen, I have already heard that some of our members may delay launching their boats until water levels improve. If water levels do become an issue this year, we will do what we can to accommodate as many members as possible.



Once our docks are in place, we plan to take water depth readings at the entrance and back of our docks and also the middle of our harbor. I will need some help and a row boat to do this so give me a call at 366-1123 if you would like to participate.

I am also open to suggestions as to how to get meaningful depth readings. We can take portable sonar readings but that may only give us depths to the top of the mud/silt. I would also like to know the depth to the "hard bottom" that could damage props. My plan at this time is make a depth instrument using a 2"X 2" X 8 ft board graduated in inches with a 12" X 12" piece of plywood attached to the bottom. I plan to add some weights to the plywood to give it negative buoyancy and push it down to a hard bottom. This is just my plan at this time but I am very open to other ideas!

In addition to possible water issues affecting dock availability, we also have members (floaters and new members) who have submitted Dock Applications for 2013. We will try to accommodate as many members as possible by enforcing our bylaws. If you were a dock holder in 2012 and plan to hold a dock again in 2013, please make sure to turn in a Dock Application before our dock assignment meeting in early March and also make sure that you are a member in good standing, i.e. you have the required 18 volunteer hours in 2012 (or paid the \$20/hr), and are in good standing regarding GBYC fees. If you have a dispute regarding hours, fees, etc, call me at 366-1123 before our dock assignment meeting.

The 2012 member hours sheets are located in the top drawer just below the big screen TV in the bar area.






