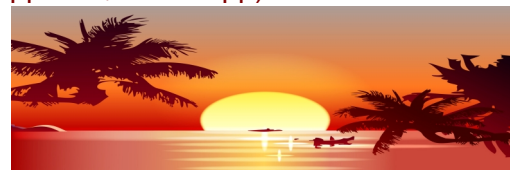

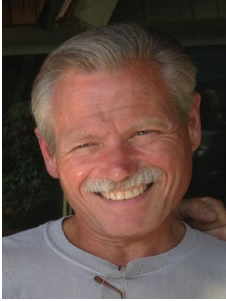

It was greatly appreciated! We got a lot of positive feedback and learned a few things we should do differently. I am glad to get such positive feedback about the band performance. I think we can agree they really rocked the place and if the 2015 Luau volunteers step up now, they may be able to book them again. I don't know who you are, but I know who you are not. But I will help. Many of you asked for the shredded turkey recipe. There isn't one. It is called " eat while you cook till you like it". But to get started; I roast the turkey upside down for moistness. Put extra water or broth in pan, you will want a lot of good rich gravy. Once cooled, shred it, skim the fat off the broth and use cornstarch to make the gravy. If it needs something, add a little salt , pepper and poultry seasoning at a time until you have the flavor you want. If you need to make the broth richer and want to use bouillon, I recommend " Better than Bouillon" brand and sodium free "Herb-ox" mixed.

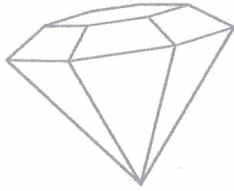
