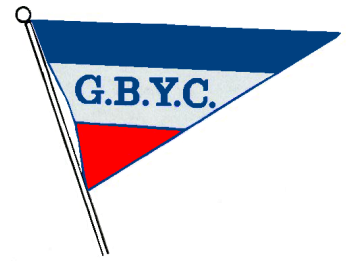

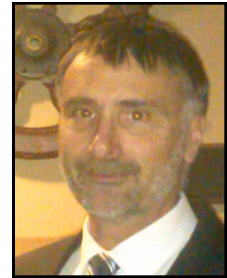

Greetings from the Commodore Gary Kuschel



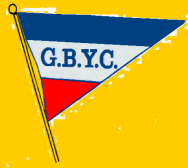

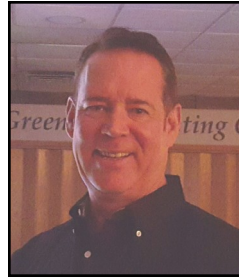

(Let us know if your insurance changes in the future.)

Requests for a dock, both from previous dock holders and from new applicants, must be submitted by February 1st, 2016. The assignment committee will honor requests for a new slip/location as best as possible. However, in order to make best use of the harbor we may assign slips based on size, i.e. large boat = large dock, small boat = small dock. Docks will not be assigned to members not in good standing i.e. has not completed the requisite hours in the previous year or is past due on dues or fees. Dock fees must be paid in full by the due date on the invoice and prior to launching boat.

All dock applications from current dock holders must include a \$250.00 non-refundable deposit and be submitted by February 1st. Balance of the dock fee is due prior to lift-in or May 1st. Failure to pay all fees by due date will result in full dock fee payment with dock application the following year and dock re-assignment will be at the discretion of the Fleet Captain.
